She is currently the Chair of the House of Delegates and a member of the Executive Council of the Nebraska State Bar Association. She is also a Fellow and Board Member of the Nebraska Bar Foundation. Ms. O'Brien is also the managing partner of the firm.

Of all the affiliations Melany is deeply involved with, she is most proud of the work she does with the Women's Center for Advancement (WCA). "Being on that board, I feel we're doing so many meaningful things to help people get out of abusive situations, and as you know, Hauptman O'Brien provides free cab rides for someone who's in an abusive situation.
